

## PERSONAL DATA PROTECTION NOTICE

This Personal Data Notice (“Notice”) describes how Fairy Park Group of Companies (“Fairy Park”) (the list of companies in this group is listed below with its headquarters at No 181A, Jalan Meru, 41050 Klang, Selangor) uses your Personal Data.

By engaging Fairy Park to provide services or by interacting with Fairy Park either at our events, talks or otherwise, or by using the Fairy Park website [www.fairy-park.com](http://www.fairy-park.com) (“Website”), or voluntarily providing your personal information by filling up any of our forms or entering into any contract with us, you consent to the processing of your Personal Data by Fairy Park and all persons involved in the provision of services by Fairy Park.

Fairy Park shall have the right to modify, update or amend the terms of this Notice at any time by placing the updated Notice on its Website. By continuing to communicate with Fairy Park or by continuing to use Fairy Park’s services following the modifications, updates or amendments to this Notice shall signify your acceptance of such modifications, updates or amendments.

In the event of any conflict between the English and other language versions, the English version shall prevail.

### Collection of Personal Data

1. “Personal Data” means information about you which you have provided to Fairy Park, such as your name, address, telephone number, NRIC, email address, your personal preferences, particulars of your spouse or family members and bank account information and any information which may identify you, your spouse or family members that has been or may be collected, stored, used and processed by Fairy Park from time to time.
2. In addition to the Personal Data you provide to Fairy Park directly (i.e. during your communications with Fairy Park and/or when you engage Fairy Park to provide services), Fairy Park may also collect your Personal Data from a variety of sources, including without limitation at any events, conferences, seminars or talks organised or sponsored by Fairy Park and/or from the cookies used on the Website.
3. The provision of your Personal Data is voluntary. However, if you do not provide your Personal Data, Fairy Park may not be able to (i) communicate with you; (ii) provide you the services you require or (iii) access certain sections of the Website where log in is required.

### Purposes of Processing

4. Fairy Park may use and process your Personal Data for the purposes relating to the services you have requested and for the business activities of Fairy Park which shall include, without limitation:-
  - a) to communicate with you;
  - b) to respond to questions and comments from you;
  - c) for internal administrative purposes;
  - d) to provide information to regulatory and governmental authorities in order to comply with statutory and government requirements, including disclosure to the Unclaimed Money Management Division of the Accountant General’s Department of Malaysia of your information as required pursuant to the Unclaimed Moneys Act 1965 and regulations in the event of any unclaimed monies on your part;
  - e) for Fairy Park to comply with its obligations under law, including compliance with laws relating to evidence; and you agree and consent to Fairy Park using and processing your Personal Data in the manner as identified in this Notice.

### Other purposes

5. Fairy Park may also use and process your data for other purposes such as:-
  - a) to send you information, promotions, updates and materials such as newsletters, articles, write-ups as well as other updates via any appropriate medium such as;
  - b) to distribute information or details of sales, promotions, new products or services which may of interest to you;
  - c) to send as potential referees to potential clients who request for referees of past services; by way of email, mail, Whatsapp messages, Short Message Services or such other modes of communication available at the relevant time.

6. If you do not consent to Fairy Park processing your Personal Data for the purposes listed in Section 4, please notify Fairy Park using the contact details stated in Section 9 below.

#### **Transfer of Personal Data**

7. As Fairy Park's information technology storage facilities and servers may be located in other jurisdictions, your Personal Data may be transferred to, stored, used and processed in a jurisdiction other than Malaysia. You understand and consent to the transfer of your Personal Data out of Malaysia as described herein.

#### **Disclosure to Third Parties**

8. Fairy Park may engage other companies, service providers or individuals to perform functions on Fairy Park's behalf, and consequently may provide access or disclose to your Personal Data to the third parties such as those listed below (not exhaustive):
  - a) information technology (IT) service providers;
  - b) data entry service providers;
  - c) storage facility providers;
  - d) banks and financial institutions;
  - e) insurance providers;
  - f) any professional advisors and external auditors;
  - g) Fairy Park's lawyers
  - h) Regulatory and governmental authorities in order to comply with statutory and government requirements, including to the AGD for the purposes as described in Section 4 above.

#### **Access & Correction Requests and Inquiries**

9. Subject to any exceptions under applicable laws, you may at any time hereafter request for access to, or for correction or rectification of your Personal Data or limit the processing of your Personal Data, or seek further information from Fairy Park by contacting:-
